# **Portland Donut Club**

#### Article I: Name

This club shall here forth be referred to as the Portland Donut Club of the University of Portland or PDCUP.

## Article II: Purpose

The purpose of this club is to revel in the donut wonderland that is Portland Oregon though sharing the culture of this great city with fellow students. We hope to educate and interest students into learning more about Portland through the celebration and exploration of local neighborhoods and of course, the donuts found within.

## Article III: Membership

All enrolled undergraduate students at the University of Portland are eligible to be a part of the *Sugary Goodness*. The *Sugary Goodness* consists of all voting members of PCUP. Graduate students, faculty, and staff are eligible to be non-voting members of PDCUP and they will be given the title of *Old Fashioned*, and can not outnumber the *Sugary Goodness*.

As a Registered Student Group at the University of Portland we adhere to the University's Non-Discrimination Policy. This group provides equal treatment and opportunity to all persons without regard to race, color, religion, national origin, sex, age, genetic information, disability, or veteran status except where such distinction is required by law. Additionally, the Office of Student Activities prohibits discrimination on the basis of sexual orientation, gender identity or gender expression.

## Article IV: Officers

The Original Glaze (President):

- · Plans out activities and agenda of the meetings
- · Plans fundraising events for club members

The Voodoo Doll (Vice President/ Secretary) :

- Keeps an updated roster of the active members of the Sugary Goodness
- Records official meeting minutes
- Conducts the election and record the results
- Publicize events of the club, manage social media account, and advertise meetings

The Pip's Mini (Treasurer):

- Organizes and presents budget to executive board members and ASUP
- Chairs fundraising events

Charter Adopted February 26, 2017 Amended July 10, 2019 If the Original Glaze position is vacated, then the responsibilities of the position fall to the Voodoo Doll until the position can be refilled with a special election. If the executive board members or the members of the *Sugary Goodness* would like to recall an officer: then a unanimous officer vote is required and a simple majority (50% +1) of the *Sugary Goodness*.

### **Article V: Elections**

Elections for officers will be held during the last week of March. For a vote to be valid, 2/3 of the *Sugary Goodness* must be in attendance. A simple majority is needed for a candidate to be elected.

#### **Article VI: Meetings**

Meetings will be held every other week. In order for a meeting to be valid, 1/2 of the *Sugary Goodness* must be present.

#### Article VII: Disbandment

If this club or organization were to disband for any reason, any club materials or supplies purchased with ASUP funds will be returned to ASUP, and those funds obtained from fundraising or club dues will be returned to the university after three years of group inactivity.

#### **Article VIII: Amendments**

All amendments to this Constitution must be introduced at a valid meeting, first. Then, the amendment must pass unanimously among the executive officers of the club. Lastly, the amendment was be voted on and approved by 2/3 of the *Sugary Goodness*.
