

## 2022-2023 TYPE 2 AIR FORCE ROTC POLICY – UNIVERSITY OF PORTLAND For students admitted to UP in 2020-21 and beyond

### **2022-2023 Type 2 Air Force Tuition Coverage (Fall/Spring)**

Students receiving a Type 2 AF ROTC scholarship are limited to receive the original institutional merit scholarship, UP Grant, and Anchor Award, (if any) they were awarded upon acceptance to the University (other institutional awards are not eligible to be combined with room scholarships) plus the \$9,000 AF ROTC payment each semester up to base tuition, professional tuition and class fees.

Students are required to cover the following with federal/state or outside scholarship aid or with their own funds: Health and Counseling Fee and Student Activities Fee and Health Insurance (if it cannot be waived), meal plan, transportation, books/supplies and personal expenses, leadership class fees, fine art lab fees, or private music or voice lessons.

Students are required to file a FAFSA each year and must make satisfactory academic progress per the Financial Aid Satisfactory Academic Progress Policy.

### **Air Force Room Coverage (Fall/Spring)**

**Cadets living in the residence halls** actively receiving an ROTC scholarship will have their UP Air Force ROTC Room Scholarship award amount calculated using the following formula:

*Total standard room charges (not including amenities fees) capped at \$5,415 each semester (fall/spring).*

Cadets with a 3-year scholarship will receive the room cap in full their freshman year, regardless of other aid, so long as they are otherwise eligible for aid.

ROTC cadets living in residence halls may be required to give up their room over winter break for use by another student.

**Married Cadets not living in the residence halls** have the following scholarships based on their situation:

- **Married cadets whose spouse is not an UP ROTC cadet and who are approved for a University owned off campus house:** The room scholarship per semester will be the 5 month per-room University rent charge + \$675 (estimated utilities \* 5 months).
- **Married cadets who are married to another UP ROTC cadet and who are approved for a University owned off campus house:** The combined room scholarship per semester will be the 5 month per-room University rent charge(s) + \$675 (estimated utilities \* 5 months).

### For students admitted to UP in 2020-21 and beyond

- **Married cadets whose spouse is not an UP ROTC cadet and who are denied a University owned off campus house:** The room scholarship per semester will be \$5,415 (equivalent to a standard on-campus room).
- **Married cadets who are married to another UP ROTC cadet and who are denied a University owned off campus house:** The room scholarship per semester will be \$5,415 (equivalent of standard on-campus).

A copy of the marriage certificate and, in the case of those not living in University-owned off campus housing, confirmation of the denial from Residence Life are required to receive married, off-campus awards.

Married cadets who are living in non-University owned off campus housing must be enrolled full time. An exception will be made for graduating seniors in their final semester; however, they will have their room scholarship prorated.

### **ROTC Summer Term Room Scholarship Policy for Nursing Students**

UP ROTC room scholarships will be provided only to nursing students during the required summer semester between the junior and senior years. UP ROTC room scholarship for summer semester will be paid as follows:

- **Unmarried cadets & married cadets living in the residence halls:** The room scholarship is capped at the University residence hall charge for a Standard Room for the duration of their required summer courses. Student must be living in the residence hall to receive the room scholarship.
- **Married cadets whose spouse is not an UP ROTC cadet and who are approved for a University owned off campus house:** The room scholarship per semester will be the per-room University rent charge for the duration of their required summer courses + \$405 (estimated utilities \* 3 months).
- **Married cadets who are married to another UP ROTC cadet and who are approved for a University owned off-campus house:** The combined room scholarship per semester will be the per-room University rent charge for the duration of their required courses + \$405 (estimated utilities \* 3 months).
- **Married cadets who are denied a University owned off campus house:** The room scholarship is paid at \$3,441 per cadet for the summer (estimated off-campus rent \$3,036 from FA COA \* 3 months + estimated utilities \* 3 months \$405).

A copy of the marriage certificate and, in the case of those not living in University-owned off campus housing, confirmation of the denial from Residence Life are required to receive the award.

**For students admitted to UP in 2020-21 and beyond**

**Restrictions to the above**

A FAFSA is required to receive the University of Portland provided ROTC scholarships.

University of Portland (UP) institutional ROTC related funds are contingent upon the student receiving and validating their ROTC Scholarship from the Air Force (AF) and is evaluated every semester. While student is receiving any AF ROTC Scholarship Type, they are not eligible to receive any institutional funds (including, but not limited to, merit awards and UP Grant funds) other than the AF ROTC Room Scholarship and the Air Force Tuition Discount.

ROTC room scholarships are not available for studies abroad or for students using VA Education Benefits.

In cases where the AF ROTC Scholarship is suspended or the student is dis-enrolled from the ROTC program, the student may have any UP Merit Award, UP Grant or Anchor Award funds that were awarded to them as an incoming student reinstated, assuming they still meet the University's Financial Aid requirements for Satisfactory Academic Progress (SAP).
