

# Important notice affecting the University of Portland Retirement Program

Effective October 2, 2013, the University of Portland is making several changes to the current investment options offered under the retirement program.

### What this means to you

- New investment options will be introduced.
- Several investment choices will be closed and replaced with new options.
- Two investment options will be closed to new contributions and replaced with new options for future contributions

## What will happen next

#### 1) New investment options will be added

Starting October 2, 2013, new investment choices will be added to your retirement program. These new options may offer you more flexibility to create a retirement portfolio that's tailored to your investment preferences and goals.

#### 2) Several investment options will be closed and replaced with new options.

Effective October 2, 2013, the University of Portland is removing several investment options and replacing them with new investment options. In addition, several investments will be closed to future contributions.

These new options may offer you more flexibility to create a retirement portfolio that's tailored to your investment preferences and goals. See the charts below to understand how your current assets and any future contributions may be affected.
