What is UP Today?

University of Portland (UP) is a thriving community of more than 4,000 students who come from around the nation and the world, as well as over 1,000 faculty and staff. The University is located on a bluff in a residential neighborhood overlooking the Willamette River and the city of Portland. The school's location also is the inspiration for its nickname, "The Bluff."



University is currently led by Acting President and Provost Dr. Herbert A. Medina. Since our inception in 1901, the University has been guided by the Congregation of Holy Cross, a Catholic order of priests and brothers. The founder of the order, Blessed Basil Moreau, CSC, said, "The mind will not be cultivated at the expense of the heart." This commitment to educating the hands, heart, and mind are hallmarks of our belief in educating the whole person.

Mission

The University of Portland, an independently governed Catholic university guided by the Congregation of Holy Cross, addresses significant questions of human concern through disciplinary and interdisciplinary studies of the arts, sciences, and humanities and through studies in majors and professional programs at the undergraduate and graduate levels. As a diverse community of scholars dedicated to excellence and innovation, we pursue teaching and learning, faith and formation, service and leadership in the classroom, residence halls, and the world. Because we value the development of the whole person, the University honors faith and reason as ways of knowing, promotes ethical reflection, and prepares people who respond to the needs of the world and its human family.

National Recognition

For 26 consecutive years, the University has earned a top-10 ranking by US News & World Report in the "Regional Universities – West" classification, including the <u>Number 3 spot in the</u> <u>2021 rankings</u>. For nine consecutive years, University of Portland has been <u>the top Oregon</u> <u>school in Kiplinger's Personal Finance</u> annual ranking of best values in private universities. And for three consecutive years, *Bloomberg Businessweek* has named University of Portland the top school in Oregon for "return on investment" in a state-by-state ranking of schools providing graduates with the most return for the price of their education.

Academics

University of Portland is Oregon's only comprehensive university with schools of business, education, engineering, nursing, a college of arts and sciences, and a graduate school. There are more than 40 undergraduate programs and 30 minors, as well as 18 graduate programs, and more than 1,300 courses. The University features small class settings (12:1 student-faculty ratio) and award-winning faculty. The University was recognized as the top producer of Fulbright U. S. Students in the nation among master's level institutions, according to an annual study by the *Chronicle of Higher Education*. University of Portland ranks first nationally in Fulbright U. S. awardees for academic year 2020-21, with 10 students receiving prestigious grants to study, conduct research, and/or teach English abroad.

The University offers a rich resource for the community through educational opportunities, research, and experts, in addition to a host of engaging events such as athletic games, cultural events, speakers, and lectures.

College & Schools

College of Arts & Sciences

The College of Arts and Sciences (CAS) provides the "core" education in the liberal arts for all students at University of Portland and offers 26 majors and 20 minors through 14 departments. Besides its responsibility for the core program, the College of Arts and Sciences supports the professional schools through courses in



mathematics, physics, biology, communication studies, English, and other disciplines. Graduate programs are offered in communication studies, drama, and theology.

Pamplin School of Business

The Pamplin School of Business offers a collaborative learning environment that develops students' knowledge of effective business practices, enhances their analytic and interpersonal skills, and enables them to be successful and ethical leaders in their

Air Force ROTC

The Air Force Reserve Officer Training Corps (AFROTC) program at University of Portland is an educational program designed to give men and women the opportunity to become Air Force officers while completing a bachelor's or master's degree. Air Force ROTC offers numerous programs

Army ROTC

Army ROTC provides prerequisite leadership training qualifications for students desiring to earn appointments as second lieutenants in the United States Army, the United States Army Reserve, or the Army National Guard. The military science classes are elective courses that use a combination of academics and hands-on training to



teach students leadership, responsibility, and teamwork. These classes add management training, practical experience, and personal growth opportunities to a student's education.

Student Life

Believing that education takes place both inside and outside the classroom, University of Portland places a strong emphasis on residential living with approximately 95 percent of firstyear students and 55 percent of the total student body living in one of the University's 10 residence halls, including the newest hall, the Lund Family Hall, which opened in fall 2016.

The University's commitment to an education outside the classroom means that University of Portland offers a wide variety of extracurricular programming including an inclusive Campus Ministry program; local, national, and international volunteer opportunities through the Moreau Center; fitness, intramurals, and outdoor activities through the recreation services program in the Beauchamp Recreation and Wellness Center; and an active student government, Associated Students of the University of Portland.

Athletics

The Portland Pilots are members of the West Coast Conference and compete at the NCAA Division 1 level. There are sixteen intercollegiate teams: baseball (M), basketball (MW), cross country (MW), rowing (W), soccer (MW), tennis (MW), indoor and outdoor track and field (MW), and indoor and beach volleyball (W). There are currently 276 student-athletes at University of Portland, with 57% of them being women and 43% men.

Alumni

University of Portland alumni are resources for research, internships, and full-time employment. More than half of University of Portland's 42,000 alumni reside in the Portland/Vancouver metropolitan area. There are currently 21 active alumni chapters (regional, academic, affinity, and online) in 10 states across the country that play vital roles in support of University of Portland's Catholic Holy Cross and academic missions. This includes serving as ambassadors for University of Portland and advocates of student recruitment in their respective areas.

University of Portland, founded by the Congregation of Holy Cross in 1901, is a Roman Catholic, comprehensive university with a core curriculum rooted in the liberal arts. The Board of Regents and campus community are seeking nominations and applications for the Presidency of this outstanding University. Following the words of Blessed Basil Moreau, the Congregation's founder, who stated: "The mind will not be cultivated at the expense of the heart," the University has been educating students' hands, hearts, and minds for 120 years. The University offers a remarkable leadership opportunity for its next President. In faithfulness to its mission, institutional values, and the charism and traditions of the Holy Cross founders, the next President will set the stage for an even brighter future by executing the following leadership priorities:

Advance and Promote the Mission

In furtherance of the University's identity as a Roman Catholic, Holy Cross, comprehensive university with a liberal arts core and foundations in the Catholic Intellectual Tradition, our President will promote the integration of faith and reason as ways of knowing, encourage ethical reflection, and prepare people to respond with hope to the needs of the world and its human family. The President will be a champion and promoter of the spiritual, moral, and intellectual tenets of the University's mission, both on the University campus and beyond.

Maintain a Relationship with the Holy Cross Congregation

As director of a Holy Cross ministry, the University's President will maintain and advance the University's relationship with the Congregation of Holy Cross, and will further the values of building community, promoting social justice, maintaining solidarity with the poor, educating for the common good, and respecting the dignity of all people.

Build Community & Articulate a Bold, Unifying Shared Vision

Our President will build community and a sense of belonging both on and off campus among faculty, staff, students, alumni, Regents, the Holy Cross

Congregation, and others by inspiring trust and articulating a bold and unifying long-term vision for the University. The shared vision will provide direction, inspiration, hope, and enthusiasm for a promising and progressive future in the ever-changing and uncertain higher education landscape. The vision will simultaneously build on traditions *and* embrace positive change, with the goal of enhancing the University's already sterling reputation for touching hearts, stimulating minds, and cultivating leadership as it prepares students for life, work, and service.

Further Long-Term & Comprehensive Financial Sustainability

The University occupies a position of financial strength. Nevertheless, it is not immune from financial challenges that are common among institutions matching its profile. This includes costs associated with the pandemic, demographic and corresponding enrollment challenges and opportunities, greater competition for students, and students' increased financial support needs. To assure future financial stability, our President will build upon and strengthen existing strategies, including optimizing enrollment, building the endowment, creating new revenue initiatives, and skillfully shepherding expense management.

Advance the University's Commitment to Diversity, Equity, Inclusion, & Justice

The University is proud to be a diverse community grounded in Catholic social and moral teaching, committed to social justice, and resolute in its belief that all people are deserving of dignity and respect. Our President will actively lead and support University partners in continuing to build a sense of belonging and furthering diversity, equity, inclusion, and justice by intentionally attracting, welcoming, and supporting an even more diverse and inclusive student body, faculty, administration, and staff. Our President will also actively engage an ever-morediverse alumni community, ensuring that they, too, feel a true sense of support, fulfillment, and belonging.

Contribute to and Advance the University's Strategic Plan

Using a collaborative process and a steering committee comprised of individuals from across the institution, the University is presently creating a new, clear, and compelling Strategic Plan (the Plan). The Plan is expected to chart the University's direction for the next five years. Our new President will have the opportunity to contribute to the finalization of the Plan and set its execution in motion by working with the campus community to further develop and refine its strategic objectives, implementation strategies, and accountability metrics. The President will also be charged with using imagination and creativity to anticipate and address future changes across higher education to enable the University to act quickly and expand its unique place in and beyond the Northwest.

Strengthen and Renew Our Commitment to Academic Excellence

Alongside faculty and University leadership, our President will imagine and embrace a shared academic vision that continues to focus on excellence, relevance, and potential opportunities for expansion. The vision will encourage innovation in academic programming to respond to regional, national, and global educational needs, and promote faculty development and greater effectiveness in instructional strategies. The President will collaborate with the Provost, faculty, and leadership to articulate a common understanding of what distinguishes a University of Portland education, and how it provides an exceptional, relevant, and student-centered transformational experience to a diversity of learners. The President will be an advocate for the indispensability of a faith-based college education that is rooted in the Catholic Intellectual Tradition, and that leverages the University's recently revitalized liberal arts core curriculum.

Stimulate Our Culture of Philanthropy Among Internal and External Constituencies

In partnership with the University's development professionals and others, fundraising will be an essential priority for our President. The President will lead and stimulate philanthropic initiatives across the University and create a culture of giving among Regents, parents, alumni, faculty, staff, students, friends, and external stakeholders. Partnering with development to raise money through donations, grants, the annual fund, and capital campaigns is essential. In addition to positioning the University to successfully undertake its next capital campaign, the President will establish new corporate and nonprofit partnerships in and around the Portland area, along the West Coast, throughout the country, and beyond.

Strengthen Student Enrollment, Retention, and Success

In order to sustain financial vitality, our President will position the University to reach optimal enrollment, retention, and student success goals. This includes promoting the University's distinct mission and the charism of the Holy Cross Congregation as that which differentiates the University from peer institutions. It also includes encouraging University-wide responsibility for intentionally attracting a diverse student population and developing initiatives to inspire and assess student retention and success.

Strengthen University Culture and Unity

Community and solidarity are core institutional values at University of Portland. As the institution navigates a world filled with social unrest, a global pandemic, and increased focus on diversity, equity, inclusion, and justice, it is critical that the President strengthen and inspire a more resilient University community filled with hope, belonging, and purpose. This includes engaging a diverse group of stakeholders around mission-aligned institutional priorities, strengthening shared governance relationships, embracing transparency and communication, and promoting a unified commitment to institutional success.

Invigorate and Support the Alumni Community

The University is blessed to have an active, engaged, committed, and accomplished community of alumni. The President will work with campus partners to strengthen and sustain the ties between the institution and its alumni, view alumni as true partners in building a stronger University, and support practices and initiatives that engage and leverage alumni connections and perspectives for the betterment of the institution. Finally, our President will actively pursue strategies to support UP alumni, professionally and personally, even after their time on The Bluff has concluded.

Advance the University's Commitment to Being an Employer of Choice for Talented and Diverse Staff and Faculty

Our President will work closely with Human Resources, the Provost, and other campus partners to support and champion University employees. In a dynamic and challenging employment market, creative strategies must be implemented that make UP a true "employer of choice," where employees are fulfilled and supported, and where they feel that they are truly valued collaborators in advancing the University's mission. The President will also contribute to long-standing efforts to ensure that employees of diverse backgrounds are recruited, retained, nurtured, supported, and valued.

Sustain and Advance the University's Student-Centered Approach to Intercollegiate Athletics

The next President will believe in the power of intercollegiate athletics to improve the lives of students and contribute to community vibrancy and pride. The leader must adopt an approach to Division I athletics that centers student-athlete wellbeing and success. The President must collaborate with others to lead a compliant, competitive intercollegiate athletics program that serves as a positive and effective ambassador for the institution.

Desired Presidential Attributes

The University's President will be a committed Catholic who demonstrates a deep commitment to the institution's mission. The President will model servant leadership reflective of the charism of the Congregation of Holy Cross. A terminal degree and a record of distinction in progressively responsible leadership roles are required. The President will possess an astute understanding of the challenges facing twenty-first century Catholic higher education. Being an inspiring, collaborative, and visionary leader with emotional intelligence and an uncompromising work ethic are also essential.

The University's next President also will be:

VISIONARY AND MISSION-DRIVEN: A proven and mission-driven servant leader who will understand, embrace, and be energized by the University's mission and the charism of the Congregation of Holy Cross, and capable of effectively communicating both within and outside the University community. The President will encourage diverse groups of University stakeholders to consider new directions by promoting widespread understanding, inclusivity, trust, and support around a compelling and inspiring vision for the University's future.

STUDENT FOCUSED: An individual with a student-centered focus who genuinely enjoys campus life and is committed to the Holy Cross belief that education occurs in classrooms, in residence halls, in the community, and around the globe. The President must be a champion of the University's "Big Three": (1) teaching and learning; (2) faith and formation; and (3) service and leadership. The President also must be committed to student success and providing a transformative, values-centered academic experience that creates lifelong learners and prepares students to be ethical leaders who contribute to the betterment of society.

A PROVEN LEADER IN DIVERSITY, EQUITY, INCLUSION, & JUSTICE: A

progressive and culturally aware leader with a proven track record that demonstrates a commitment to promoting diversity, equity, inclusion, and justice, and who will enthusiastically and dynamically further such initiatives at the University. Our President must be able to effectively articulate the University's DEIJ commitment, and how that commitment is linked inextricably to its Catholic, Holy Cross identity.

AN EXCEPTIONAL COMMUNICATOR: An exceptional listener and outstanding communicator, our President will have the ability to engage effectively with a diverse group of individuals and enthusiastically share the University's story. The President will be energized by serving as the University's chief spokesperson, have a comfortable and compelling public presence, and possess excellent written, oral, and interpersonal communication skills.

A SKILLED DECISION MAKER: A skilled and analytical decision maker capable of assessing the University's strengths and challenges, prioritizing competing needs, and envisioning new opportunities. The President will have the courage to ask hard questions and make difficult but sound and mission-aligned decisions consistent with strategic priorities and available financial resources.

PASSIONATE ABOUT EDUCATION & FACULTY WORK: A lifelong learner committed to the inherent value of a comprehensive university that possesses both a liberal arts focus and excellent professional programs, who welcomes engaging with faculty, values scholarship, and believes in the importance of shared governance for institutional effectiveness.

A SKILLED FINANCIAL LEADER: A leader who understands the fiscal complexities of a comprehensive academic institution, including the need for careful management of annual operations, oversight of endowment and treasury functions, and holistic resource stewardship. The President will have experience working successfully with budgets comparable in size and complexity to that of the University, and with long-term financial planning. To ensure financial sustainability, the President will be fiscally responsible, action-oriented, forward thinking, creative in considering alternate revenue sources, and a data-informed decision maker who is capable of allocating finite resources among competing needs in a transparent and unifying manner.

A PROVEN FUNDRAISER: A proven and eager fundraiser who will partner well with the University's development team to energize future capital campaigns, build new relationships, represent the University in and beyond Portland,

motivate a diverse group of stakeholders, and stimulate a robust culture of philanthropy on and off campus.

COMMITTED TO SHARED GOVERNANCE: A visible and collaborative leader, the University's next President will have experience leading in an environment of shared governance and will demonstrate an authentic understanding of the value communication, open-dialogue, collaboration, and transparent decision-making brings to relationship building and trust.

AN EMPOWERING EXECUTIVE: A knowledgeable administrator with the organizational leadership skills, experience, and insight needed to effectively lead the University by building and empowering successful teams and direct reports; appreciating, supporting and strengthening faculty and staff; developing talent; encouraging mutual respect through transparency; hiring well; and, incorporating administrative and governance "best practices" and procedures into leading the University community.

A TRUSTED PARTNER WITH THE BOARD OF REGENTS: The Board of Regents is deeply committed to the University's mission. The President will share an open and trusted partnership with the Board, further Regent mission formation, and be committed to "best practices" in Regent relations and the conduct of the Board.

A COMMUNITY LEADER BEYOND CAMPUS: In addition to a strong internal presence, our President will be a community focused individual and will cultivate the public role of the Presidency by building meaningful relationships within the Portland community and beyond, all in order to promote opportunities for the University and support the institution's commitment to engage with and serve the world.
